Age Limit

No person shall be eligible for appointment to the service by direct recruitment, if he/she has completed 45 years of age or if he/she has not completed 25 years of age on the first day of January of the year in which applications for appointment are invited with relaxation as provided to Scheduled Castes/Scheduled Tribes and Other Backward Community candidates in the General Rules.

Probation

Every person appointed to any of the categories shall, from the date on which he/she joins duty, be on probation.

- i) If appointed by direct recruitment/transfer, for a total period of 2 years on duty within a continuous period of 3 years, and
- ii) if appointed by promotion for a total period of six months on duty within a continuous period of two years.

Reservation for appointment

The rules of reservation of appointment (General Rules 14 to 17) shall apply to appointments by Direct Recruitment.

Appointing Authority.

The appointing authority for the post of Assistant Professor shall be the Director of Medical Education and for the remaining posts under all categories shall be the Government.

Test


