NOTIFICATION

As per the Minutes of VC meeting with officials of NMC, MCC, NBEMS and State Counselling Authorities (NEET-PG 2024 State Specific Merit List) dated 07.11.2024, it is decided that all the State Counselling Authorities are requested to send to NBEMS the complete final data for preparation of State Specific Merit List for NEET-PG 2024 and also reported that, NBEMS will not be providing the scores of the candidates/shift wise data to any of the State Counselling authorities and any such request will not be entertained by NBEMS. NBEMS shall provide the state specific merit list in one go to all the participating State counselling authorities.

Since NEET Score was not provided by NBEMS, in order to give service weightage for the in service candidates, and also as per prospectus conditions instead of service weightage, calculating equations are given for each candidates and provisional eligibility is thus prepared. This list will be handed over to NBEMS for providing the state specific merit list.

Accordingly, the Provisional Rank List of Medical Education Service Quota Candidates for Admission to PG Medical courses 2024 is prepared and appended below.
